How can you help?

Your contribution to the new Sports Centre.



On 3rd May 2010, construction of the new Sports Centre began. Key features will include:

- A 1080 m² multi-purpose sports hall that can be divided to permit two simultaneous basketball games or left open for one six-a-side football match.
- A secondary sports/recreation hall for dance, aerobics, yoga, and judo that will allow the school to expand greatly its range of sports and recreational offerings.
- A fitness suite with cardiovascular machines, weight machines and free weights.
- One classroom equipped with multimedia equipment that will enable us to have several functions using the facility at the same time.
- A lounge for the Sixth Form.
- An indoor climbing wall to allow experienced mountaineers to hone their skills and beginners to receive instruction in a controlled environment.

Among the principal benefits will be a substantial saving of student travel time, and a greater range of flexibility in the sports curriculum, reflecting Aiglon's philosophy of a healthy lifestyle being part of the balanced development of the whole person.

The total cost of the building will be approximately CHF 9 million. Over the past few years we have held meetings with current and former parents and alumni to gauge what level of support we might have for our capital campaign, and a dozen parents have made it possible for us to raise CHF 7 million by January 2011. Two major conclusions have become apparent: that there is encouraging support for the school's dynamic and positive progress, and that a number of parents wish to participate in some way, big or small, in capital projects over the time their sons and daughters attend the school.

The main thrust of this stage of the fundraising for this new facility is the naming of specific units of the building including the seats. Major donors wishing to leave a lasting legacy for their family will be acknowledged by a plaque placed on a unit of the building or on a seat. We are looking to raise another CHF 2 million by naming units of the building and the 162 seats.



Major gifts and naming opportunities

A number of substantial gifts are still being sought to allow us to reach our target. We shall be pleased to discuss named or In Memoriam gifts linking a name with a particular aspect of the facility. All gifts over CHF 25,000 will receive acknowledgement as major donors and will be identified as such on a Benefactor's Board in the Sports Hall. No amounts will be specified.

Sports Centre Naming Opportunities

For CHF 100'000+ gifts naming of the following elements can be discussed:

- The Building
- The sports halls
- The study lounge
- The school shop
- A classroom

How do I name a seat?

We hope that past and present parents, Aiglon alumni and friends of the school will wish to support us by naming the 162 retractable seats planned for the Sports Centre. It will cost CHF 10'000 to name a seat, and the donation may be spread over a number of years. This is a unique opportunity to put your name,

your family's name or the name of someone special to you onto a seat.

We can guarantee that your seat will be used over and over again by people of all ages, and your engraved plaque will be a lasting tribute to those who support and love Aiglon, its Sports and Expeditions.





How Can You Give Tax Efficiently?

Tax benefits are available for those residing in the USA or the UK and the School will direct you to our Friends of Aiglon College organisation to receive your full tax-deduction.

Tax efficient giving in Switzerland

While we are recognised as a not-for-profit association in Switzerland, tax exemption is limited to CHF 10'000 in the Canton of Vaud. Swiss residents will not be taxed for any gifts sent from a bank located outside of Switzerland.

Tax efficient giving in the USA

U.S. taxpayers should donate to Friends of Aiglon College USA enabling them to take full tax deductions. Higher rate taxpayers in the U.S. can claim unlimited personal tax relief.

Tax efficient giving in the United Kingdom

As a registered charity in the United Kingdom, the Aiglon Charitable Trust UK can reclaim tax on all donations made by UK taxpayers thus maximising the value of the gift to the school.

There is now no limit for Gift Aid donations which are the tax efficient way of giving for those who wish to make a gift or series of gifts without forward commitment. Income tax can be reclaimed. If you are a higher rate taxpayer you can also claim unlimited personal tax relief at the difference between the basic and higher rates of income tax on the gross value of your gift. This means that a higher rate taxpayer can give a quarter more than a basic taxpayer for the same cost. You can, of course, only donate by Gift Aid if you pay UK tax.

Donation by Companies in the United Kingdom

The procedure for company donations has now been greatly simplified. Companies can claim corporation tax relief on all donations to charities. For a company paying corporation tax at 30% in the UK, the net cost of a donation worth £20'000 to the campaign, could be only £14'000.

Gifts of Shares in the United Kingdom

Gifts of publicly quoted shares, in addition to being exempt from capital gains tax liability, enable the donor to claim income tax relief.

Other Gifts

Direct transfers of assets such as property and works of art do not incur capital gains tax. All outright gifts, including bequests are exempt from inheritance tax.
